

- **How to monitor your petition online** - Residency Reclassification Petitions must be monitored online at <https://one.uf.edu/> → Student Self Service → My Record → Petition Status. **All requests for additional documentation and decisions, including final decisions, will be posted here.** It is recommended students monitor their one.uf account on a weekly basis until a decision is posted. Review begins after the drop/add period ends for the applicable term, and these petitions are reviewed on a first-come, first-serve basis. The timely manner in which your decision is posted depends on the amount of petitions received and the date of your submission. If submitted by the deadline, your decision will be posted sometime during the applicable term. If your petition is approved after the fee payment deadline, you will receive a refund for the out-of-state fees and your in-state status will remain valid until you graduate or reapply to the university.
- **How to submit your petition** – Please use the following link, <http://www.registrar.ufl.edu/>, to review the deadline for submitting your residency reclassification petition. Click on the applicable catalog, graduate or undergraduate, to view your critical dates and deadlines. Applications submitted after the deadline require a written explanation for the late submission and may be deemed ineligible for review. Residency reclassification can only be applied to the current term, not retroactively to previous terms. Students' UFIDs should be written on the top right hand corner of ALL supporting documents. Students should keep a copy of all submitted residency documents for their personal records. Students do not need to resubmit copies of supporting documents that were previously submitted for prior residency petitions. Please be aware, residency documents should not be submitted by email. All residency documents must either be uploaded via the [secure upload button](#) or mailed to The Office of the University Registrar, P.O. Box 114000, Gainesville, FL 32611-4000.

## Guidelines and Standards

- The claimant must establish and maintain a legal Florida residence for at least 12 months prior to the first day of class listed in the applicable academic calendar for the petitioned term. The 12-month qualifying period requires documentary evidence as requested by the appropriate university official pursuant to 1009.21(3)(a). Examples of relevant documentation can be found on page 2 of this document.
- **In addition to the Florida legal documents listed on page 2, independent students must prove their presence in the state was for the purpose of maintaining a bona fide domicile, rather than for the purpose of maintaining a mere temporary residence or abode incident to enrollment in an institution of higher education pursuant to 1009.21(2)(a)(2) and 1009.21(6)(a).** Examples of documentation that could be used in combination with the Florida legal documents, which may help prove intent to be a permanent resident are, but may not be limited to, the following:  
  
Documentation of full-time permanent employment for the prior 12 months or the purchase of a home in this state and residence therein for the prior 12 months while not enrolled in an institution of higher education.
- Information contained in this document in no way supersedes or replaces Florida State Statute 1009.21, Board of Governors Rule 7.005, and/or the statewide residency guidelines. This document is provided merely as an informational resource only.

- Independent** – I will be claiming Florida residency based on my own Florida legal documents. **(Required:** Copy of your most recent tax return. If you are under the age of 24 enrolled in an undergraduate program, you must also provide a copy of your parent’s most recent tax return and documentary evidence you provided more than 50% of your cost of attendance.)
- Dependent** – I will be claiming Florida residency based on my parent’s or legal guardian’s Florida legal documents. **(Required:** Copy of your parent’s or legal guardian’s most recent tax return. If you are above the age of 24, you must also provide documentary evidence your parent or legal guardian provided more than 50% of your cost of attendance. For a child to qualify as a dependent of a parental adult other than the biological parent or legal guardian the child must have resided continuously with the adult for the 3 years immediately prior to the student’s initial enrollment in an institution of higher education, during which time the adult exercised day-to-day care, supervision, and control of the child pursuant to 1009.21(2)(b).)
- Married** – I will be claiming Florida residency based on my spouse’s Florida legal documents. **(Required:** Copy of marriage certificate, spouse’s and student’s Florida legal documents.)

**Please provide copies of your Florida legal documents.** It is highly recommended the claimant provide as many of the following as possible, as no single document can guarantee an approval. Evidence of legal residence must include clear and convincing documentation that the claimant established and maintained permanent legal residence in Florida for at least 12 consecutive months prior to the first day of class listed in the applicable academic calendar for the petitioned term. To obtain some Florida residency documents, the claimant may be required to relinquish legal documents or ties to his/her former state (E.g. Driver’s license, vehicle registration, voter’s registration, etc.). Maintaining legal documents or ties to another state during the evaluated 12 months may result in the denial of the claimant’s residency claim.

**Exceptions and Qualifications**

**Students meeting any of the following criteria shall be classified as a Florida resident for tuition purposes and do not need to show proof of 12 months residence in Florida. If you meet the requirements for one of the following exceptions, please check the appropriate box and attach the required documentation listed below.**

- Persons who are enrolled as Florida residents for tuition purposes at a Florida public institution of higher education, but who abandon Florida domicile and then re-enroll in Florida within 12 months of the abandonment – provided that he/she continuously maintains the re-established domicile in Florida during the period of enrollment. (This benefit only applies one time.) [s.1009.21(9), F.S.] (Required: Copy of enrollment verification or official transcript.)
- Active duty members of the Armed Services of the United States residing or stationed in Florida (and spouse/dependent children); active drilling members of the Florida National Guard; or military personnel not stationed in Florida whose home of record or state of legal residence certificate, DD Form 2058, is Florida (and spouse/dependent children). [s.1009.21(10)(a), F.S.] (Required: DD Form 2058.)
- Active duty members of the Armed Services of the United States and their spouses/dependent children attending public college or university within 50 miles of the military establishment where they are stationed, if such military establishment is within a county contiguous to Florida. [s.1009.21(10)(b), F.S.] (Required: Copy of military orders.)
- United States citizens living on the Isthmus of Panama, who have completed 12 consecutive months of college work at the Florida State University Panama Canal Branch, and their spouses and dependent child. [1009.21(10)(c), F.S.] (Required: Copy of enrollment certification and marriage certificate or proof of dependency.)
- Full-time instructional and administrative personnel employed by the State public school system and institutions of higher education as defined in [s.1009.21(10)(d), F.S.] (and spouse/dependent children). (Required: Copy of employment verification.)
- Students from Latin America and the Caribbean who receive scholarships from the federal or state government. The student must attend, on a full-time basis, a Florida institution of higher education. [s. 1009.21(10)(e), F.S.] (Required: Copy of scholarship papers and residency status form from the UF international center.)
- Southern Regional Education Board's Academic Common Market graduate students attending Florida's state universities. [s. 1009.21(10)(f), F.S.] (Required: Certification letter from state coordinator.)
- Full-time employee of state agencies or political subdivision of the state whose student fees are paid by the state agency or political subdivision for the purpose of job-related law enforcement or corrections training. [s. 1009.21(10)(g), F.S.] (Required: Copy of employment verification.)
- McKnight Doctoral Fellows and Finalists who are United States citizens. [s. 1009.21(10)(h), F.S.] (Required: Verification from Graduate Studies.)
- United States citizens living outside the United States who are teaching at a Department of Defense Dependent School or in an American International School and who enroll in a graduate-level education program, which leads to a Florida teaching certificate. [s. 1009.21(10)(i), F.S.] (Required: Copy of enrollment verification or official transcript.)
- Active duty members of the Canadian military residing or stationed in this state under the North American Air Defense (NORAD) agreement, and their spouses and dependent children, attending a public community college or university within 50 miles of the military establishment where they are stationed. [s. 1009.21(10)(j), F.S.] (Required: Copy of military orders.)
- Active duty members of a foreign nation's military who are serving as liaison officers and are residing or stationed in this state, and their spouses and dependent children, attending a Florida College System institution or state university within 50 miles of the military establishment where the foreign liaison officer is stationed. [s. 1009.21(10)(k), F.S.]
- I am a qualified beneficiary under the terms of the Florida Prepaid College Program (s. 1009.98, F.S.). (Required: Copy of Florida prepaid ID card.)

**Student Financial Statement**

Students under the age of 24 enrolled in an undergraduate program claiming independent status are required to complete this financial statement. In addition to the financial statement, these students must attach documentary evidence proving they provided at least 51% of their cost of living for the 12 months prior to the students' first day of class for the petitioned term.
